Board Action Details 08/11/2021 BOARD ORDER - License to practice medicine and surgery indefinitely suspended for at least five years, and subject to an eighteen thousand dollar (\$18,000.00) fine, conditions for reinstatement or restoration, and probationary terms, conditions and limitations for at least five years. Upon completion of probation and restoration, the doctor's license is subject to a permanent limitation and restriction prohibiting the doctor from prescribing, writing orders for, giving verbal orders for, administering, or personally furnishing any controlled substance. Based on the finding the doctor's plea of guilty in the United States District Court, Southern District of Ohio, Eastern Division, to one felony count of Illegal Dispensing of Schedule II Controlled Substances, and one felony count of False Statements Relating to Health Care Matters, individually and/or collectively constitute a plea of guilty to, a judicial finding of guilt of, or a judicial finding of eligibility of intervention in lieu of conviction for, a felony. Order effective 8/26/21.
